

MELCO INT'L DEV<00200> - Unusual price & volume movements

The Stock Exchange has received a message from Melco International Development Limited which is reproduced as follows:-

"This statement is made at the request of The Stock Exchange of Hong Kong Limited.

We have noted the increases in the price and trading volume of the shares of the Company today and wish to state that, except for the matters specified below, we are not aware of any reasons for such increases.
