On 16 December 2009, the Company entered into a deed of amendment (the “Deed of Amendment”) with Great Respect Limited (“Great Respect”) to amend the terms of the HK\$1,175 million in principal amount of convertible loan notes due 2010 issued by the Company to Great Respect. The amendments contemplated by the Deed of Amendment, including the adjustment of the conversion price from HK\$9.965 to HK\$3.93 and the extension of the maturity date from 4 September 2010 to 4 September 2013, became effective on 18 February 2010. The total number of shares of the Company which would be issued on exercise in full of the conversion rights under the amended convertible loan notes would increase from 117,912,694 shares to 298,982,188 shares.
