ANNOUNCEMENT

1. Certain shareholders of EGT have filed in the United States District Court for the Southern District of New York a complaint (the “**Complaint**”) against EGT and certain current and former directors and officers of EGT; and
2. In addition to EGT and its directors and officers, the Company and its wholly-owned subsidiary, Elixir Group Limited (“**EGL**”), were also named as defendants in the Complaint.

The Company and EGL have appointed US legal counsel to consider and advise them on the claims set forth in the Complaint. The Company and EGL intend to defend themselves vigorously against the claims and allegations contained in the Complaint.
