38,000,000 share options to Mr. Ho, Lawrence Yau Lung, the Chairman and Chief Executive Officer, an			
Executive Director and a substantial shareholder of the Company, under the share option scheme of the			
Company was not passed by the independent shareholders of the Company. As a result, the condition for the			
proposed grant of a total of 76,158,000 share options to the directors of the Company (including the grant of			
38,000,000 share options to Mr. Lawrence Yau Lung) and certain executives, management staff, employees and			
consultants of the Company and its subsidiaries was not fulfilled and the proposed grant of options to the said			
persons did not proceed.
