GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The Board of Directors of the Company announces that on 2 April 2013, the Company granted a total of 7,724,000 share options (the “**Options**”) to the directors and certain employees and consultants of the Company (collectively, the “**Grantees**”), subject to acceptance of the Grantees, under the Company’s share option scheme adopted on 30 May 2012. The Options will entitle the Grantees to subscribe for a total of 7,724,000 new shares of HK\$0.50 each (the “**Shares**”) of the Company. A summary of the grant is set out below:-

Exercise price of Options granted : HK\$13.40

Number of Options granted : 7,724,000

Closing price of the Shares on the date of grant : HK\$13.20

Validity period of the Options : Ten years, from 2 April 2013 to 1 April 2023

Vesting date of the Options : (i) 2,185,000 options granted may be exercised on or after 2 April 2013;
(ii) another 2,185,000 options granted may be exercised on or after 2 April 2014;
(iii) another 1,678,000 options granted may be exercised on or after 2 April 2015; and
(iv) a further 1,676,000 options granted may be exercised on, or after 2 April 2016.
