Cultivates youth as tomorrow's leaders with positive life values

(Hong Kong, April 24, 2012) – Melco International Development Limited ("Melco" or the "Group," HKEx Code: 200), a long-time keen supporter of charity events and community services, issued its fifth Corporate Social Responsibility ("CSR") Report ("the CSR Report") for Year 2011. During the year, Melco embarked on more than 40 charitable projects benefiting nearly 24,000 children, youths, their families and the physically challenged.

Mr. Lawrence Ho, Group Chairman and Chief Executive Officer of Melco said, "We made tremendous progress in achieving our CSR objectives in 2011 and take great pride in the recognition of our efforts to become a more socially responsible organisation. Two of our many awards included the '5 Years Plus Caring Company Logo' from the Hong Kong Council of Social Service and recognition by *FinanceAsia* as one of the best CSR organisations in the region. All of these accomplishments have ignited our passion to go the extra mile in 2012 and beyond. I would like to take this opportunity to thank our NGO partners, CSR Committee and, most of all, our staff volunteers who have done so much to realise Melco's vision of inspiring hope and happiness in people all over the world."

The CSR Report, entitled "Empowering YOUTH for a BETTER FUTURE," expresses the Group's particular attention to the growing social issues related to youth development in 2011. The hero program, a 10-month Adventure-Based Counselling ("ABC") project, was a joint effort with Youth Outreach enabling 150 deprived youths to develop self esteem and to embrace positive life values.

Sir Roger Lobo, Chairman of the CSR Committee said, "Youth development continued to be our main CSR focus this year, as the need for outreach to our younger generation has not grown less. We are particularly concerned about 'double loss' (unschooled and jobless) youths and the increasing rate of substance abuse among them. We believe that by allocating more resources towards these young people, we can help them face challenges, build self-esteem and become society's future leaders."

Melco's CSR strategy is based on its core charity pillars, namely, Youth Development, Environment and Education in Hong Kong, Macau and China. Over the years, the Group has increased its efforts in CSR, while maintaining the focus on business growth. Committed to operate as a responsible corporate citizen, Melco takes a proactive approach in answering community and youth needs by participating in a wide range of activities and encouraging staff volunteerism through innovative measures. Last year, the Group encouraged staff members to invite their family members and friends to become Friends of Melco Volunteers, resulting in a 90% increase in total volunteer hours.

Melco is among the very few companies in Hong Kong that publishes an annual CSR report in order to communicate the Group's CSR vision, strategies and achievements with its stakeholders. This year, the Group has also enclosed a sporty "In the running for YOU" wristband with the CSR
