**MELCO PBL ENTERTAINMENT TO BE EIGHTH WONDER'S GAMING
PARTNER IN ITS PROPOSED SENTOSA INTEGRATED RESORT**

[SINGAPORE, Oct 10, 2006] - Las Vegas-based Eighth Wonder, a privately held company that conceives, designs and develops entertainment and leisure resorts, retail complexes and casinos, is pleased to announce Melco PBL Entertainment - the joint venture between Publishing and Broadcasting Limited (PBL) of Australia and Melco International Developments Limited (Melco) of Macau and Hong Kong as its partner in its bid for the Sentosa Integrated Resort (IR).

PBL is Australia's largest diversified gaming, media and entertainment group with a market capitalisation of more than USD\$10 billion. Melco PBL Entertainment, in addition to being an equity partner in the proposed Eighth Wonder Sentosa IR, will operate *Crown Casino* and also an exclusive six-star *Crown* branded hotel should the Eighth Wonder consortium win the bid. *Crown Casino* at Eighth Wonder's proposed Sentosa IR will feature an exciting range of games in a first class property to complement the outstanding range of attractions at Eighth Wonder's Sentosa IR. *Crown Towers Hotel* will be the ultimate in luxury hotels and will offer the best in service and facilities which the *Crown Towers* name has become renowned for throughout Asia.

PBL's Executive Chairman and Co-Chairman of the Melco PBL Entertainment, Mr. James Packer said: "I have never seen a gaming and leisure project more innovative and ground breaking than Mark Advent's concept for the Sentosa IR - I believe that it will redefine the design of integrated resorts globally.

"PBL has extensive experience in operating large scale casino resorts in major cities with the involvement and support of the local community. *Crown Casino* has successfully operated in Melbourne for 12 years which is a city similar in size to Singapore. PBL will ensure that *Crown* continues to maintain its international reputation of being a good corporate citizen who contributes to the local community.

"With a well-developed customer and player base of *Crown* in Melbourne, we are confident that there will be significant synergies with our Singapore property at the Eighth Wonder Sentosa IR, should we be awarded the bid at the end of this year."
