New Arrangements on Dissemination of Corporate Communications

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”), the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) and the articles of association of Melco International Development Limited (the “**Company**”), the Company has adopted new arrangements to disseminate its future Corporate Communications² electronically.
